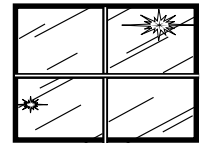

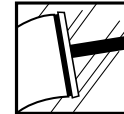

DILUTION TABLE
Dilute 6.5 oz./gal. or 47 mL/L (1:20) with water.
