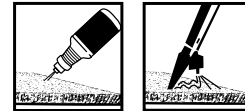

DIRECTIONS FOR USE

Read the entire label before using this product.

Be sure to test in an inconspicuous area before using. SPOT REMOVAL (RED STAIN AND TANNIN TREATMENT): Apply directly to spot. Allow to set for 5 - 10 minutes. Blot with an absorbent white cloth. Apply #3 Betco Alkaline Conditioner to the spot to neutralize the pH. Extract or shampoo the area. Vacuum when dry. DEBROWNING: Dilute 4 oz./gal. or 31 mL/L (1:32) with water. shampoo or extract the carpet as usual. Do not overwet. Vacuum when dry. POST CLEANING ACID RINSE: Dilute 1 oz./gal. or 8 mL/L (1:128) with water. Extract the carpet as usual.

SAFETY

Keep out of reach of children. For institutional and commercial use.

WARNING: Severe skin and eye irritant. Avoid contact with skin and eyes. Wear suitable gloves and chemical anti-splash goggles. FIRST AID: If splashed on skin or in eyes, flush with large quantities of water for 15 minutes. If inhaled, get to fresh air. If swallowed, dilute with large quantities of water.
